Fall Winefest Vendor Information

Montage Mountain Resorts is set to host the ninth annual Montage Mountain Fall Wine Festival on Saturday October 5, 2024! We'll be featuring top Pennsylvania Wineries to sample from 100s of wine varietals while enjoying live entertainment, unique cuisines, and retail vendors setup around the resort. Guests can take advantage of our "Wine Check" & pick up your wine purchases near your car when exiting festival... "Hands free is the way to be!" Wine Check is available for those purchasing 3 or more bottles from the same vendor.

Partnership

Vendors will be selected and announced after the application process is finalized. A limited number of vendors will be selected to participate in this year's festival allowing for good product variety and maximized vendor profitability. Vendor load-in will take place at 9:00am the day of the event, or any time after noon the day before. Generators or any other fuel/gas/burning equipment are not allowed indoors. Outdoor generators must run quiet and vent away from the festival grounds. Load out will be limited to 60 minutes after the event.

Each vendor will be provided with two (2) festival wristbands and two (2) tasting glasses. Vendor staff are required to be 18+ years of age and must be 21+ to receive the items listed above as well as participate in any samplings. Wineries will be asked to donate 10 bottles of wine in addition to their vendor fee to be considered for acceptance.

Vendor staff and affiliated parties must be present throughout the festival and must adhere to the guest service standards Montage Mountain puts in place. All members of the event, regardless of company or affiliation, agree to work toward the overall success of the event as a whole and understands that experience as a whole is more valuable than the sales at any single booth.

Partnership is very important to the team at Montage Mountain. We ask that vendors of all types help in promoting the event in shops, social media, and through word of mouth. Options are available to sell tickets to the event through consignment at no cost upfront. Vendors with the interest and ability to promote the event with us get preference in future considerations and festival placement.

TERMS & CONDITIONS

Please complete the enclosed application and return it no later than August 30, 2024.

All applications received will be reviewed, and management reserves the right to accept/deny participation in the event for any or no reason at all.

Applications will be reviewed based on a number of criteria including but not limited to completeness, previous event involvement, marketing reach, vendor variety, timeliness of application, ability to provide equipment, and clarity of information. When listing "products offered" it is important to be thorough and detailed as your mix influences participation in the event and provides information for festival marketing leading up to the event.

An accepted application is commitment to the festival and no refunds will issued in the event participation falls through. If an application is not accepted, the vendor fee will be returned at that time. Your check will not be cashed until your application has been accepted by the festival organizers.

Electricity and other supplies are available on a limited basis and must be requested on your application. Management reserves the right to deny requests due to limited availability. Please include all fees when returning your application. **Wineries will be asked to donate 10 bottles of wine in addition to their vendor fee to be considered for acceptance.** Cardboard boxes are the only acceptable wine check carrier, and those using paper/cloth/plastic will be responsible for replacing any broken bottles during transport. Vendors are responsible for collecting PA State Sales Tax on all applicable items.
